1. APOLOGIES FOR ABSENCE - Cllr. Cobb

2. **DECLARATIONS OF DISCLOSABLE PECUNIARY INTERESTS** – None

3. REVISED ESTIMATES FOR FINANCIAL YEAR 2021-2022

3.1 The Clerk reported on the projected financial position at 1 April 2022.

3.2 Although there were some items of expenditure which had gone over-budget, there had been underspends in several budget codes due to the ongoing coronavirus pandemic. This means that the General Reserves in 2022-2023 should be sufficient to allow flexibility in planning expenditure for the next financial year, including the pavilion project.

4. BUDGET ESTIMATES FOR FINANCIAL YEAR 2022-2023

The Clerk presented a report giving details of budgeted income and expenditure for 2022-23 and explained the items where the budget differed from last year.

- 4.1 It had been assumed for draft budget purposes that the precept would be little changed so as to keep the total precept the same as 2021-22, which , due to the change in the council tax base figure, would slightly decrease the cost for householders, i.e. the Band D figure would decrease from £57.23 to £56.63.
- 4.2 The Clerk had assumed nominal or no increases in many budgets details were provided within Appendix 2 and 3.
- **4.3** Background to the Clerk's salary and the Village Warden's hourly wage were provided in Appendix 4.
- **4.4** Members of the Committee agreed estimated figures in Appendix 2, except 4140 (Software) which was increased to £500.
- **4.5 It was agreed that** the following amounts from the following budget headings be transferred into Ear Marked Reserves (EMR) on 1 April 2022.

£200 from 4211 – Defibrillators to 322 EMR – Defibrillators

£1,500 from account code 4302 – Traffic Schemes to 334 EMR – Traffic Schemes

£2,000 from 4306 - Bollards to 331 EMR - Bollards

£200 from 4320 – Litter Bins to 326 EMR – Asset Replacement

£1,000 from 4341 - Notice Boards to 326 - EMR Asset Replacement

£250 from 4342 - Salt Bins to 326 - EMR Asset Replacement

£500 from 4355 - Benches to 326 – EMR Asset Replacement £1000 from 4360 - Planned Tree Maintenance to 335 EMR - Trees £500 from 4415 – Forest Side BMX Dirt Track to 330 EMR – BMX refurbishment/maintenance £500 from 4422 The Links Play Area to 324 EMR – Play equipment £200 from 4425 – Playing Fields Litter Bins to 326 – EMR Asset Replacement £13,000 from 4429 – Playfield Road Pavilion Project to 329 EMR – Pavilion Project £500 from 4453 – War Memorial Maintenance to 333 EMR – War Memorial £1,500 from 4502 – Bus Shelters to 326 EMR – Asset Replacement

- 4.7 It was agreed that the Clerk's salary would stay on salary point 23, in line with the national scales. It is hoped that the new scales for 2022/2023 will be published closer to the time, although the scale for 2021/22 has not yet been confirmed.
- **4.8 It was agreed that** the Village Warden's salary would stay on salary point 6, in line with the national scales.
- 5. NEW EXPENDITURE FOR FINANCIAL YEAR 2022-2023
- **5.2** The following items were suggested:
 - Replacement storage estimated cost £5,000
 - Bus shelter for north end of Kennington Road (south facing stop) estimated cost £3,000
- 6. TO APPROVE LIST OF DIRECT DEBIT PAYMENTS
- **6.1** The 2022-23 list of Direct Debit payments was provisionally approved.
- 7. PARISH PRECEPT FOR FINANCIAL YEAR 2022-2023
- **7.1** The provisional council tax base for 2022-23 is £1,714.00 for Kennington Parish.
- 7.2 A proposal was made by Cllr. Patterson to raise the precept by 4.2%, in line with the Consumer Price Index for October 2021, to £101,147, which was seconded by Cllr. Johnston and agreed unanimously.
