

**OXFORDSHIRE COUNTY COUNCIL
(KENNINGTON AND SOUTH HINKSEY) (SPEED LIMITS) ORDER 20****

The Oxfordshire County Council, in exercise of its powers under Sections 82, 83 & 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby make the following Order.

1. This Order may be cited as the Oxfordshire County Council (Kennington and South Hinksey) (Speed Limits) Order 2023 and shall come into force on the day of 202*.
2. No person shall drive any vehicle at a speed in excess of 20 miles per hour in any of the lengths of road specified in Schedule 1 to this order.
3. No person shall drive any vehicle at a speed in excess of 30 miles per hour in any of the lengths of road specified in Schedule 2 to this order.
4. No person shall drive any vehicle at a speed in excess of 40 miles per hour in any of the lengths of road specified in Schedule 3 to this order.
5. No speed limit imposed by this Order applies to a vehicle falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011, being a vehicle used for naval, military or air force purposes, when used in accordance with regulation 3 (5) of those regulations.
6. The Oxfordshire County Council (Kennington and South Hinksey) (Speed Limits) Order 2023 is hereby revoked.

SCHEDULE 1

20mph speed limit:

Kennington

PART A

The whole length of every road in the village of Kennington (excluding those lengths of road listed in schedules 2 and 3) extending to the following points:

a)	Cranbrook Drive	its junction with The Avenue
b)	Edward Road	its junction with Kennington Road
c)	Grundy Crescent	its junction with The Avenue
d)	Kenville Road	its junction with Kennington Road
e)	Manor Grove	its junction with The Avenue
f)	Playfield Road	its junction with The Avenue
g)	Poplar Grove	its junction with The Avenue
h)	Sandford Lane	its junction with The Avenue
i)	Simpson Way	its junction with The Avenue
j)	St Swithuns Road	its junction with The Avenue and Bagley Wood Road
k)	Upper Road	its junction with Kennington Road

PART B

l)	Bagley Wood Road	from a point 35 metres west of its junction with Kennington Road, south-westwards	to a point 218 metres southwest of its junction with St Swithuns Road

South Hinksey

a)	Manor Road	its entire length
b)	St Lawrence Road	its entire length

SCHEDULE 2

30mph speed limit:

Kennington

a)	Kennington Road / The Avenue	from a point 316 metres north of its junction with Upper Road, southwards	to the Radley parish boundary, a point 17 metres north of its junction with Sandford Lane.
b)	Kennington Road - A423 Southern Bypass Road slip road	from its junction with Kennington Road, north- eastwards	for a distance of 53 metres,
c)	Foxcombe Road	From its junction with Hinksey Hill/Oxford Road, south-westwards	for a distance of 100 metres.
d)	Old Abingdon Road	from a point 70 metres southwest of its junction with the A4144 (Abingdon Road), south-westwards	to a point 108 metres northeast of its junction with Kennington Road, partly in the City of Oxford.

Kennington and South Hinksey

a)	Hinksey Hill / Oxford Road	From a point 183 metres northeast of its junction with Spring Copse, south- westwards	to a point 160 metres south of its junction with Foxcombe Road
b)	Betty Lane	From its junction with Hinksey Hill, north & eastwards	for a distance of 200 metres.

SCHEDULE 3

40mph Speed Limit:

Kennington

a)	Foxcombe Road	from a point 100 metres southwest of its junction with Hinksey Hill/Oxford Road, south-westwards	to a point 20 metres northeast of its junction with Red Copse Lane.
b)	Oxford Road & A4183	From a point 160 metres south of its junction with Foxcombe Road, south-westwards	for a distance of approximately 740 metres to a point 74 metres north of its junction with Dunmore Road / Twelve Acre Drive, Abingdon, partly in the parish of Radley.
c)	Bagley Wood Road	from its junction with Oxford Road, eastwards	to a point 218 metres southwest of its junction with St Swithuns Road.

SCHEDULE 4

50mph Speed Limit:

Kennington

a)	Oxford Road	from a point approximately 900 metres south of its junction with Foxcombe Road/ Hinksey Hill, southwards	to its junction with and continuing on the A4183 Oxford Road in the parish of Radley (over the A34 interchange) to a point 94 metres north of its junction with Dunmore Road / Twelve Acre Drive, Abingdon.
